

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site [www.bolpatra.gov.np](http://www.bolpatra.gov.np). Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Pre-bid meeting shall be held at **Nijgadh Municipality Office, Bara** at **2:00 PM on 2073/12/11**
5. Sealed or electronic bids must be submitted to the office **Nijgadh Municipality, Bara** by hand/courier or through PPMO website [www.bolpatra.gov.np](http://www.bolpatra.gov.np) on or before **12:00 Noon on 2073/12/21**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00 pm on 2073/12/21** at the Nijgadh Municipality Office, **Bara**. Bids must be valid for a period of **120 (One hundred and twenty) days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 5,12,000.00** (In Words: Five lakhs twelve thousand only) which shall be valid for 30 days beyond the validity period of the bid.
