Nijgadh Municipality invites sealed bids or electronic bids from Nepalese eligible bidders for the construction of Road Construction Works Sahid Hiralal Marg, Nijgadh, Bara under National Competitive Bidding procedures. The estimated amount for the works is Rs. 1,67,96,305/- (Without Vat) (Sixteen Millions seven Hundred Ninty six Thousand Three Hundred Five Only).

A complete set of Bidding Documents may be purchased from the office Nijgadh Municipality, Nijgadh, Bara and the office Nijgadh, Bara by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of Rs. 3000/- till 2076/02/13 Bs during office hours.
Or
Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost(as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Pre-bid meeting shall be held at Nijgadh Municipality, Bara at 2076/02/02 Bs 2:00 PM.
5. Sealed or electronic bids must be submitted to the office Nijgadh Municipality, Bara by hand/courier or through PPMO website www.bolpatra.gov.np/egp on or before 12.00 on 2076/02/14 Bs. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2076/02/14 Bs 2:PM at the office of Nijgadh Municipality, Bara. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid amounting to a minimum of Rs. 504,000/- (Five Lakhs Four Thousand only) (2 to 3 % of estimated amount inclusive VAT), which shall be valid for 30 days beyond the validity period of the bid (i.e. 2076/02/14 Bs.)
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
